## **STUDIO RULES**

- **FEES AND PAYMENTS**

Fees' are due from January to December (12 months). Fees' are payable monthly, termly or yearly. Invoices will be sent out from the 25<sup>th</sup> of each month and are strictly payable by the 1<sup>st</sup> of each month. Late payments will be subject to a R50 penalty fee which will be applied to the following months' invoice. EFT payments are preferable, and all Proof of Payments are to be emailed to [beetge5@gmail.co.za](mailto:beetge5@gmail.co.za). One months' written notice and one months' fees are due when wishing to terminate this contract. Notice will not be accepted during the months of NOVEMBER and DECEMBER.

- **EXAMS, SHOWS AND EISTEDDFODS**

All exams, shows and eisteddfods are an additional charge and are not covered by monthly fees. Exam fees are set by the AIDT and are to be paid six weeks prior to the date of the exam. A register will be maintained to monitor attendance. A certain standard of dance needs to be attained and is expected. If I feel that a candidate has missed too many lessons, they will either be withdrawn from the exam session (with no refund) or private lessons will need to be arranged at an additional fee of R50/ 30min lesson.

Auditions will be held for shows and eisteddfods. A contract, signed by both the parent and the pupil, will be drawn, stating that all rehearsals (unless due to serious illness), will be attended.

- **DANCE ATTIRE**

All leotards and dance accessories are available from Lorraine at RAFSPA. Footless Grecian honey tights and a navy-blue leotard are standard attire for MODERN & TAP DANCE classes. Pink tights and a pink leotard are for BALLET classes and HIP HOP classes, the Ridgewood PT uniform may be worn. No shoes are required but takkies may be worn for Hip Hop. Hair is to be neatly tied back. NO BAGGY CLOTHES will be permitted. No CHEWING GUM is allowed. Water bottles, filled with water, are essential. (Please no fizzy cooldrinks). Water will be sold at the studio at R10 per bottle.

- **WATCHING DAYS**

Parents are permitted to watch the 1<sup>st</sup> lesson of each month. Please remain quiet during the lesson as to not distract the pupils. Siblings may not run around in the studio. Please collect your child directly after their lesson. All 'lost property' will be kept at the studio for a period of 1 month after which it will be donated. I will not be held responsible for any loss of personal belongings.

- **DANCE SYNERGY ETIQUETTE**

1. Bullying of a fellow dancer is strictly prohibited.
2. All dancers will conduct themselves in a professional manner.
3. Please arrive a bit early for your lesson. If you happen to be late- quickly get ready and stand at the door until the teacher acknowledges you and invites you in.
4. No talking during class. There should only be 3 sounds during class, music, the teacher and the SOFT swish of footwork.
5. When you are dancing, watch your spacing. Do not stand too close or in front of other dancers. If you start to travel, keep the space between you and others respectfully so that they can also dance full out.
6. ALWAYS thank your instructor/examiner.
7. REMEMBER!! Practice makes permanent!
