Payments and Rules

- Fees are due by the 5th of each month.
- Overdue accounts will be sent out via e-mail should you not receive the e-mail or have a change of e-mail address we must be notified.
- Fees must be paid monthly.
- Fees will not be deducted for absenteeism, public holidays or Private/Public school holidays.
- Upon Registration there is a R300.00 non refundable registration fee. This includes your budo pass (book)
- Fee structure: Based on class and age of student.
- Proof of payment must be e-mailed or received via sms.
- Students choosing to pay cash must make payment at the first class of each month.

- The enrolment form must be completed and signed
- **FORMS MUST BE HANDED IN WITHIN ONE (1) WEEK OF ENROLMENT.**
- Where fees are unpaid and legal action is necessary, these costs will be debited to your account.
- Fees are subject to a yearly increase and no discussions will be entered into.
- Kindly forward one month's written notice or payment in lieu thereof on termination of the contract.
- Notice of temporary or permanent absence must be given.
- Students must have proper Ju-Jitsu attire in each class. Hair must be tied back securely and no jewellery is allowed.
- No student is to leave the dojo without permission or without a parent (if under the age of 15).
- Ten minutes grace period will be accepted for latecomers. However, due to safety (lack of warm-up) and class disturbance, no one may join a class in progress after that time.
- No gum is permitted in the dojo.
- No shoes are permitted on the matted area.
- **No food is permitted in the dojo.** You may bring cold drinks or water in reseal able bottles and disperse of them in the bins provided once you are finished with them. Please ensure you clean up after yourself.
- All Gi's (uniforms) are to be kept clean and tidy at all times.
- Personal hygiene is to be maintained at all times. Toe nails and finger nails are to be kept short.
- No jewellery is permitted on the mat
- Long hair is to be tied up
- There is no smoking permitted in front of the dojo. We are setting an example for the children and are promoting a professional and healthy environment.
- Please do not interrupt a class in progress.
- If a problem should arise with your child please inform Sensei Sam Tonkin as soon as possible. Please do not approach other instructors.
- Missed Classes: Everybody misses classes for one reason or another but is important that you attend your regularly scheduled class. There are no refunds for missed classes.
